1. I agree that all Farm activities, including but not limited to goat yoga, horse yoga, caring for horses and horseback riding and hay wagon riding are inherently dangerous activities AND that these activities will expose me to above normal to high risks of bodily injury and/or death, and that I am responsible for my own safety while on the Farm property and while engaging in any and all activities. I agree to wash my hands and or child's hands after touching animals to avoid getting sick. I agree to spray myself and my child to help prevent ticks and mosquitoes that may carry disease.

2. I understand the risks involved in equine and all farm activities and I AGREE TO ASSUME ANY AND ALL RISKS INVOLVED IN GUEST'S USE OF OR PRESENCE UPON FARM PROPERTY AND FACILITIES while engaging in any equine activity and all other activities without limitation and including the risks of death, bodily injury, property damage, falls, kicks, bites, unavailability of emergency medical care, and/or the ordinary negligence and/or deliberate act of Farm or any other person.

3. I agree that Crossing Bridge Farm, Rose Bridge Farm Fox Hunt Farm and any associated organization and / to rescue and /or farm all farms stable, all agents, volunteers, employees, and invitees, (RELEASEES) are NOT liable for any injury to or the death of Rider and/or participant in any equine and or any farm activities resulting from the inherent risks of equine and farm activities

4. I agree to hold the farms including Horse and Goat Yoga Crossing Bridge Farm LLC Rose Bridge Farm LLC, Fox Hunt Farm LLC,, and associated farms, venue, hosts, volunteers, visitors, and employees completely harmless and not liable and release them from all liability whatsoever including acts of any COVID-19, ordinary negligence, associated with any equine and or any farm activity, goat yoga, during Rider's or participants/ visitors use or presence upon Farm's property and facilities while engaging in any and all equine and farm activities including but limited to those bases on death, bodily injury, illness and or property damage.

5. I AGREE NOT TO SUE Farm and/or Releasees in association with ANY claims, damages, costs, or expenses arising out of Rider's use or visitor or participant or presence upon Farm's property or hosting venue and facilities while engaging in any and all equine and farm activities including but limited to the based-on death, bodily injury, illness, and or property damages.

6. Rider and or guest and or participant are responsible for complete and full insurance coverage on himself/herself, personal property, and Rider's horse (if applicable). ACCIDENT/MEDICAL INSURANCE: I AGREE THAT: Should emergency medical treatment be required, I and/or my own accident/medical insurance company shall pay for all such incurred expenses.

7. Rider/guest/participant and Riders parent or guardian, (if Rider is a minor) agree that this agreement and release of liability is a contract that when signed by the parties involved will be legally binding to all parties, subject to the above terms and conditions and shall be enforced and interpreted under the laws of the state of Pennsylvania.

8. I actively am aware there are serious risk associated with equine and agritourism (agricultural tourism /agritainment (agricultural entertainment) activities including but not limited to Covid-19, pick your own, camp fire, horse yoga, goat yoga, and that the activities could result in serious or minor illness, bodily injury and or accidental death, and I actively and knowingly and voluntarily assume the risk of these activities.

9. Guest and or participant assume the risk of equine, agritourism (agricultural tourism /agritainment (agricultural entertainment) activities pursuant to Pennsylvania Law.

10. This agreement may be executed in counterparts, each of which shall be deemed an original, but all of which, taken together, shall constitute one and the same agreement.
