I acknowledge that Hiking Hound Adventures, LLC does not provide infant-size PFDs and that I am responsible for supplying one if needed. Provided sizes include: Child (33–55 lbs), Youth (55–88 lbs), and Adult (88 lbs and up).

Some rental items, including canoes, kayaks, and paddleboards, are equipped with GPS devices (such as Apple AirTags) to help locate lost equipment. Tracking is used only for recovery purposes and not to monitor individuals. By signing this waiver, you consent to the use of GPS tracking on applicable gear.
